#### Show Participation Guidelines

1. Production fees must be paid in full by October 1, 2010 and March 1, 2011 respectively. Due to the level of commitment and costs of production, the fees are non-refundable. The enrollment contract must include commitment to two performances reflecting the cost for two shows.
2. It is the responsibility of the dancers and their parents to check the rehearsal schedules. Information may change so check often. Ask your dancer about announcements made during class time. You can also check the website for times at [www.healdsburgballet.com](http://www.healdsburgballet.com)
3. Individual class time and rehearsals are valuable to the whole school's success. Excessive class absence and more than 2 missed rehearsals may cause your dancer to forfeit their part(s).

#### Fees and Service Hours PER SHOW

1 Dance- \$75.00 and minimum 6 Service Hours  
2 Dances - \$100.00 and minimum 9 Service Hours  
3 Dances - \$125.00 and minimum 12 Service Hours  
4 Dances - \$150.00 and minimum 15 Service Hours  
5+Dances-\$175.00 and minimum 18 Service Hours

Note: Family (multiple students) maximum Performance Fee is \$300.00

## Healdsburg Ballet 2010-2011 Enrollment Contract

**TUITION POLICY:** The ballet year is based on the ten month school district schedule. Therefore, the same amount is due each month regardless of holidays, school performances, etc. In the event a holiday falls on your scheduled class day you may make it up in another class during the week. Upon registration, your student is guaranteed placement in the class for the entire school year. Annual Tuition is due in full but as a courtesy you may make monthly installments.

**PERFORMANCES:** Performance fees are added to the annual tuition in advance. Additional fees will be billed if your child is added to additional dance choreography. If you choose not to have your child participate in 'T'was the Night Before Christmas or Peter Pan you must contact the Director in writing by October 1, 2010 and March 11, 2011 respectively.

**REFUNDS:** There will be no refund for voluntary withdrawal or missed classes. We make commitments to others based on your commitment to us.

**CANCELLATION:** HEALDSBURG BALLET reserves the right to cancel classes with insufficient enrollment and to substitute teachers at its discretion.
